Preface

The report on socio-economic profile of residents of Delhi (Part-II-Individual characteristics) has been prepared on the basis of data of individual members of the households collected during November 2018 to November 2019 by Directorate of Economics and Statistics, Government of National Capital Territory (NCT) of Delhi. During the survey, data of about 1.02 crore individuals from about 20.05 lakh households of Delhi has been collected. The report contains information on various indicators on individual characteristics like religion, social group wise distribution, status of health sector viz. chronic illness, medical facilities availed usually from, availing insurance facility etc., type of disability, status of vaccination in the age group of 0-5 years, transport facility, attendance in Anganwadi Centres by children & pregnant women, senior citizen pension, literacy rate, enrolment status of children in educational institutions, enrollment status of adolescent girls, reason for dropout of Adolescent Girl, Gross Attendance Ratio etc. The report has been prepared on the basis of information reported by the household member to the respective field surveyors during door to door survey.

The data in the report is presented as district wise results (local body wise in Annexure) and provides indicators of individual characteristics in Delhi. It is expected that the data generated in this report will provide necessary information to policy makers, researchers and Government to gauge the availability of infrastructure and successful implementation of social welfare schemes launched by Delhi Government from time to time.

The whole hearted participation of the officers of planning and statistical cadre designated as team leaders and supervisors, unemployed youth, part time workers and retired persons who worked as field surveyors for conduct of the field work of the survey of households in Delhi is highly appreciated. We are also grateful to all the households who made this survey a success by providing requisite information.

I place on record my special gratitude to the valuable guidance and directions received from Dr. B. K. Sharma, Advisor, Planning Department, tireless efforts put up by Central Team under leadership of Mrs. Manjubala Sahoo, Joint Director and all the officers of Planning and Statistical Cadre for providing guidance and supervision in respect of the field work by field functionaries/scrutiny of data within stipulated time. Executive Summary

A. Demographic and Social Characteristics

1. This report has been prepared on the basis of survey of 20.05 lakh households and 1.02 crore population of Delhi.
2. The population of Delhi comprises of 53.21% male, 46.77% female and 0.02% third gender population.
3. Sex ratio has been reported as 879.
4. Out of total population surveyed, 79.79% population is following Hindu religion, followed by 17.67% population following Muslim.
5. 60.52% of the population belongs to Others/General category, followed by 19.27% Scheduled Caste (SC) category and 19.27% population to Other Backward Class (OBC). Whereas Scheduled Tribe (ST) population was derived as only 0.94%.
6. The highest proportion i.e. 24.0% persons are working as Regular-wages/salaried followed by 5.42 % persons working as Other casual wage labour/ Contractual worker.
7. The Labour Force Participation rate has been reported as 48.61% whereas the unemployment rate has been reported as 16.25%.

B. Health Characteristics

8. Only 2.60% population is suffering from some kind of chronic illness such as Diabetes, Cardiac, Respiratory disease etc.
9. Out of the population suffering from any chronic illness, 36.33% of population suffering from diabetes followed by 21.75% from Cardiac illness (including Hypertension and Blood Circulatory disease) and 9.17% from Respiratory diseases.

10. 72.87% of the total persons in Delhi are normally getting their medical treatment from Government Hospitals/Dispensaries.
11. Out of total population, only 0.80% is reported to be suffering from some kind of disability.
12. Out of total disabled persons 33.43%, persons are having disability certificate and among these disabled persons 50.06% are receiving financial assistance from Government of NCT of Delhi.
13. Among children in the age group of 0-5 years, 77.54% children have received/receiving vaccination.

C. Transportation Characteristics

14. 69.80% of the population in Delhi are using Public transport (including Metro) for commuting to work place, educational institutions/other places etc.

D. Educational Characteristics

15. The effective literacy rate (for persons aged 7 years and above) is 88.54% whereas the crude literacy rate (for all ages) in Delhi is 85.78%.
16. 90.24% children in the age group 6-17 years are reported to be enrolled in educational institutions.
17. The enrolment status of children currently attending educational institutions at various age groups, namely, 6-10, 11-13, 14-15 and 16-17 are reported as 93.10%, 92.55%, 89.65% and 80.34% respectively.
18. Among enrolled children in the age group of 6-17 years, 52.54% of the children are enrolled in educational institutions run by Education Department of Delhi Government.
19. Among the children in the age group of 6-17 years, 9.76% are reported to be Out of School (dropout/discontinued/never attended).

20. The predominant reason for not attending school in the age group of 6-17 years is reported as financial constraint (29.2%).
21. Gross Attendance Ratio (GAR) at primary, upper primary/middle, secondary and senior secondary/higher secondary level of education is reported as 101.83%, 98.32%, 104.85% and 89.78% respectively.
22. 92.47% of the adolescent girls with age 11-14 in Delhi are reported to be attending educational institutions. In total, 7.53% adolescent girls in the age group of 11-14 years are out of school.
23. Among out of school adolescent girls, 6.42% are reported to be attending Anganwadi centers.
24. 28.59% of total out of school adolescent girls reported that the reason for not attending school was financial constraint.

E. Social and Welfare Characteristics

25. Among the children in the age group of 0-6 years, 55.40% children are reported to be attending Anganwadi centres in Delhi.
26. 43.28% of senior citizens are reported to be availing pension facility from Government of NCT of Delhi.
27. Among pregnant women aged 18 years and above, 47.15% women are attending Anganwadi centres in Delhi for availing healthcare

CHAPTER ONE

1.1 Introduction

Directorate of Economics & Statistics (DES) has been regularly conducting socio economic surveys in Delhi to capture vital information on various socio economic indicators. However, DES generally conducts sample surveys designed by National Statistical Office (NSO), Ministry of Statistics and Programme Implementation (MoSPI) in addition to short term evaluation studies assigned by Government of NCT of Delhi. The sample blocks (First Stage Units) are selected by Survey Design and Research Division (SDRD), Kolkata, on the basis of population census 2011. Recently, it was felt by Delhi Government that the results of sample surveys are not sufficient to depict the real time picture of requirements vis-à-vis availability of the infrastructure and social security.

It was also felt by Delhi Government that due to lack of baseline data on various socio economic indicators in respect of Households/Individuals of Delhi; a great deal of difficulty is being faced by different departments of Government of NCT of Delhi for policy formulation and implementation of schemes. Accordingly, DES, Government of NCT of Delhi was entrusted with the task of conducting survey of households in Delhi.

1.2 Coverage

The survey was proposed to be carried out in rural as well as urban Delhi on door to door basis. Rural sector of Delhi consists of 112 villages whereas urban Delhi comprised of five statutory towns viz, South Delhi Municipal Corporation, East Delhi Municipal Corporation, North Delhi Municipal Corporation, New Delhi Municipal Council, Delhi Cantonment in addition to 110 census towns.

Census town are those villages having a population of 5000 and above, at least 75% of male working population is employed in non-agricultural activities and density of population is at least 400/sq km. There were 110 such Census towns in Delhi as per Population Census-2011.

The smallest unit of survey in both rural and urban areas was the Enumeration Blocks (EBs) used in Population Census, 2011 by Office of the Registrar General & Census Commissioner, India (ORGI). However, due to lack of availability of field surveyor and conduct of Lok Sabha General Elections and coming into effect the code of conduct for Delhi Legislative Assembly Elections, the survey work had to be wind up before it's completion.

During the survey, about 20 lakh usual resident households across various sectors have been covered. The field work of the survey has been completed in about 51% of the total Enumeration Blocks in Delhi.

1.3 Objective

The survey aimed at collection of data on socio-economic indicators on door to door survey basis in lieu of sample survey in order to ascertain the availability of infrastructural i.e. educational, health, employment, social security and transport facility to rapidly increasing population of Delhi. It may be utilized by the Government for plan formulation and policy making and for implementation of various welfare schemes in respect of disabled persons, widows and to women in distress etc. and to gauge the future requirements of educational institutions, hospitals, sewage system, transport etc. in the context of rapidly increasing population of Delhi. Further, the data obtained may be used to judge the demographic changes on account of migration/immigration of households from/in Delhi. An analysis of areas of different population size with different characteristics certainly serves as a basis for Government plans and investigations in basic social capital. Besides, the data on economic activity and educational levels of the individual as collected is very important for manpower planning.

1.4 Funds

The survey is completely funded by the Delhi Government. The expenditure on the survey during the financial year 2018-19 was Rs. 4.74 crore and during financial year 2019-20 it was approximately Rs.21.87 crore. In total an amount of approx. Rs. 26.61 was spent on the survey and other related items such as payment to field surveyors, one consultant for preparing of RFP, development of web and mobile application with database analytics by hiring private agency and hiring 25 Statistical Assistant through ICSIL for survey work.

1.5 Manpower deployment and training

In order to conduct the field work of the survey of household in Delhi, DES has engaged about 6000 field surveyors (unemployed/part time/retired personnel) on short term basis. For effective supervision and timely completion of the survey, seventeen teams, each consisting of one team leader (Deputy Director/Assistant Director) and seventeen supervisors (Statistical Officers/Statistical Assistants) were deployed. Overall 17 Team leaders and 300 Supervisors of Planning/Statistical Cadre were deployed for overall supervision of the field work carried out by field surveyors. All the field surveyors as well as Team Leaders/Supervisors were imparted one day training in two parts i.e. concepts/definitions and technical training for capturing of the data through mobile application. Training was imparted during the months of November and December 2018 by the Officers of this Directorate/Planning Department.

1.6 Methodology

- i. DES has first time attempted to collect household/individual data through online mobile application.
- ii. An agency was hired through e-bidding for development of RFP document.
- iii. On the recommendation of technical committee under the Chairmanship of Additional Chief Secretary, M/s Transerve Technologies Private Limited was awarded the contract for development of mobile application for collection of data.
- iv. Mobile application viz. Transerve Data Collector was developed for canvassing of e - schedule in two parts i.e. Household characteristics and Individual details.
- v. Frame of population census 2011 was used for conducting the field work of the survey. Accordingly, Abridged House Lists (AHL) and enumeration block maps were obtained/ arranged from the Office of Director of Census Operations Delhi.
- vi. About 6000 field surveyors were appointed on short term basis. Training was imparted to field surveyors in batches.
- vii. Survey was to be conducted in all 272 wards of trifurcated MCD, 9 wards of NDMC and 8 wards of Delhi Cantonment board area.
- viii. For conduct of the field work of the survey efficiently and smoothly, 17 Teams each consisting of one Team Leader (of the level of Deputy Director/Assistant Director) and 16-17 Supervisors (of the level of Statistical Assistant/Statistical Officer) were formed.

1.7 Period of field operations

The field work of the survey was commenced with effect from 10th November 2018 but due to imposition of model code of conduct for general election for Lok Sabha 2019, field work remained suspended during March 2019 to May 2019. Due to non-availability of field surveyors the field work of the survey was terminated in the month of November, 2019.

1.8 Schedule canvassed

For the first time, Delhi Government has collected information on households through e-schedule using mobile application (Transerve Data Collector) developed by M/s Transerve Technologies Private Limited. The schedule was divided in two parts i.e. Household characteristics (house number, location particulars, ownership status household size, average monthly expenditure, basic amenities available to households etc.) and Individual details (age, sex, education, period of residency, employment status, disabilities and availability of medical facility & social security etc.).

1.9 Publicity

Wide publicity campaign was organized through print media & electronic media. Series of advertisements in the leading newspapers of Hindi, English, Urdu and Punjabi language were released for providing information & cooperation in this survey. In addition to above, publicity of the survey was made through FM channels. All the Resident Welfare Associations (RWA) were sensitized by sending letters.

1.10 Disclaimer

1. About 55% of the total projected population has been covered till the closing date of the survey. The population covered in this survey may not represent the actual population characteristics of Delhites. So, the data may be used by the users/policy makers with utmost care considering the under coverage of population to the extent of 45% of total population.
2. The data collection under the survey is not record-based, rather, based on oral information provided by the informant only. In other words, this method may involve some sort of under/over-reporting, unintended inaccuracy, recall lapse, casual approach, etc. on the part of the informants.

3. Majority of the enumerators engaged in the survey were unemployed youth followed by retired/part time personnel, who were totally new to such type of survey work.
4. Survey was subject to some amount of coverage error on account of such under-listing which is difficult to eliminate totally in massive survey operation.
5. Number of population/households covered in NDMC & Delhi Cantonment area is considerably low. So, data in respect of these two local bodies may not represent true picture of overall population.

CHAPTER TWO

CONCEPTS AND DEFINITIONS

2.1 House

House is a building or a part of building having separate main entrance from road, common passage, courtyard etc. It may be used for residential or non-residential purpose or both or even may be vacant.

2.2 Household

A Household is usually a group of persons who normally live together and take their meals from a common kitchen unless the exigencies of work prevent any of them from doing so. The persons in a household may be related or unrelated or a mix of both. However, if a group of unrelated persons live in a house but do not take their meals from the common kitchen, then they will not collectively constitute a household. Each such person should be treated as a separate household.

There may be one-member households, two-member households or multi-member households. You may come across three types of households namely, (i) Normal households, (ii) Institutional households and (iii) Houseless households. In this survey, only the normal households were covered. Institutional and houseless households are outside the coverage of this survey.

In a few situations, it may be difficult to strictly apply the definition of households as given above. For example, a person living alone in a house, whether cooking meals or not, will have to be treated as a household. Similarly, if husband and wife or a group of related persons are normally living together in a house but are getting cooked meals from outside due to some reason, will also constitute a normal household.

Institutional households like boarding house, mess, hostels, hotel, rescue home, night shelter, observation home, beggars' home, jail, *ashram*, old age home, children home, orphanage, etc. are excluded from this survey. However, the households living inside the campus of institution in the quarters are to be covered. For example: quarters of jailor, guard etc. located inside the jail premises, household of supervisor, attendant etc. located inside the premises of boarding house etc. were enumerated.

Houseless households which do not live in buildings or houses but live in the open or roadside, pavements, under fly-over and staircases, or in the open in places of worship, mandaps, railway platforms, etc., were also kept outside the coverage of this survey.

2.3 Head of the household

The head of the household for the purpose of this survey is a person who bears the main responsibility for the maintenance of the household and takes most of the decisions on behalf of the household and recognized as such in the household. The head of the household need not necessarily be the eldest male member, but can be a female or a younger member of either sex normally residing in the household.

2.4 Household premises

For this survey, household premises is defined as the dwelling unit of the household together with the courtyard, compound, garden, out-house, place of worship, garage, family graveyard, guest house, shop and offices for running household enterprises, tanks, wells, latrines, drains and boundary walls annexed to the dwelling unit which are under the possession of the household.

2.5 Reference time/ period

Normally, it is the date of enumeration of household. For some specific indicators like income, work participation etc. the reference period will be last 365 days (one year) preceding the date of enumeration.

CHAPTER THREE

DISTRICT WISE SUMMARY FINDINGS

3.1 Demography

3.1.1 Population

In demography population is the number of living human beings. India is the second most populated country in the world with nearly a fifth of the world's population. Delhi being the capital of India is a metropolitan city with heterogeneous character. As per Population Census, 2011 results Population of Delhi was 1.67 crore having 18th rank in Indian States.

1. In the survey 1.02 crore Population from 20.05 lakh Households of Delhi was surveyed. The proportion of male population has been reported as 53.21%, female 46.77% and third gender is 0.02%.

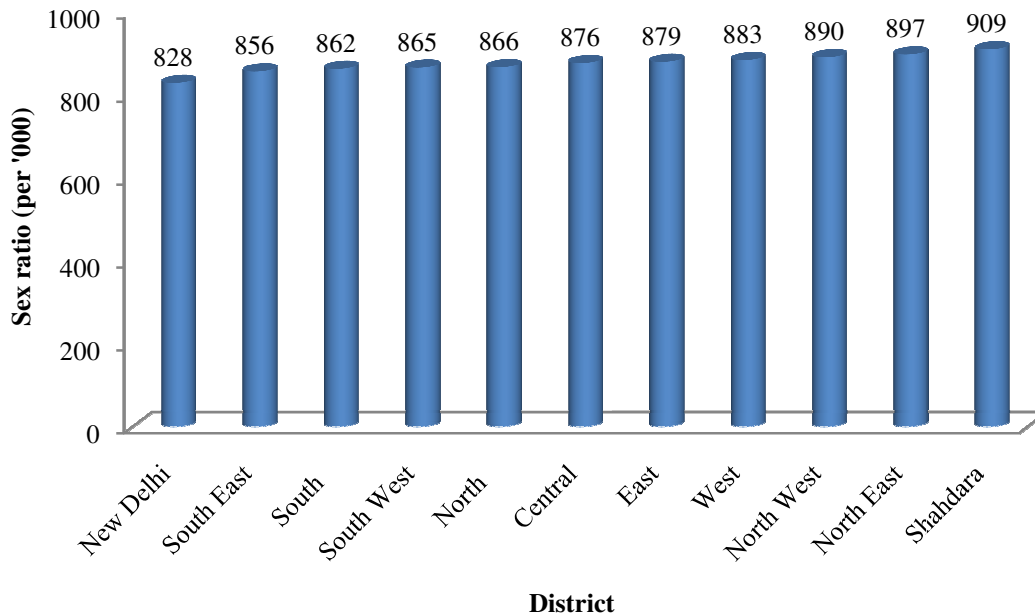
3.1.2 Sex ratio

2. Sex composition of the human population is one of the basic demographic characteristics, which is extremely vital for any meaningful demographic analysis. Sex ratio is used to

describe the number of females per 1000 of males. Sex ratio in Delhi is 879. It has been reported as 870 in rural and 879 in urban.

3. Sex ratio has been reported as 877 among Hindu population whereas it has been reported as 881 among Muslim, 928 among Sikh and 931 among Jain population (Annexure: Table 3).
4. Sex ratio among SC category population has been reported as 897 as compared to 862 in OBC category and 879 in Others/General category of population (Annexure: Table 5).

District wise sex ratio

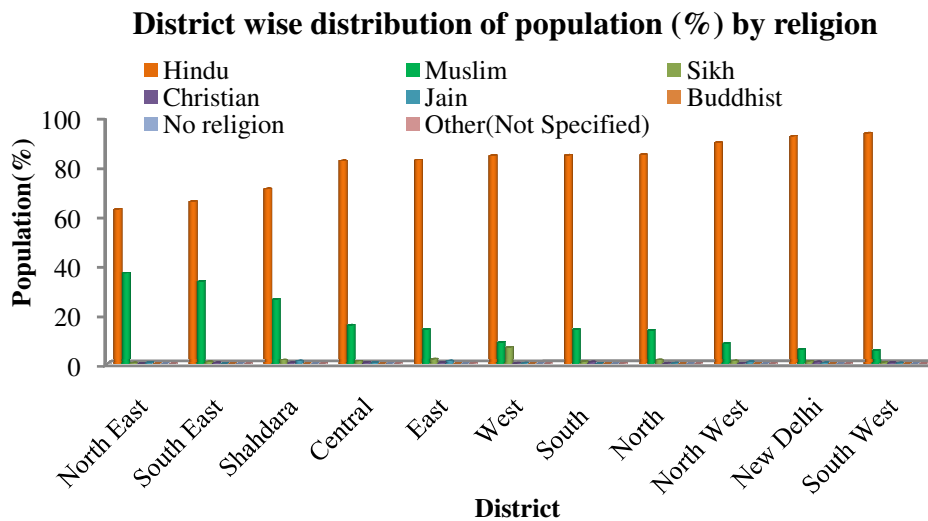
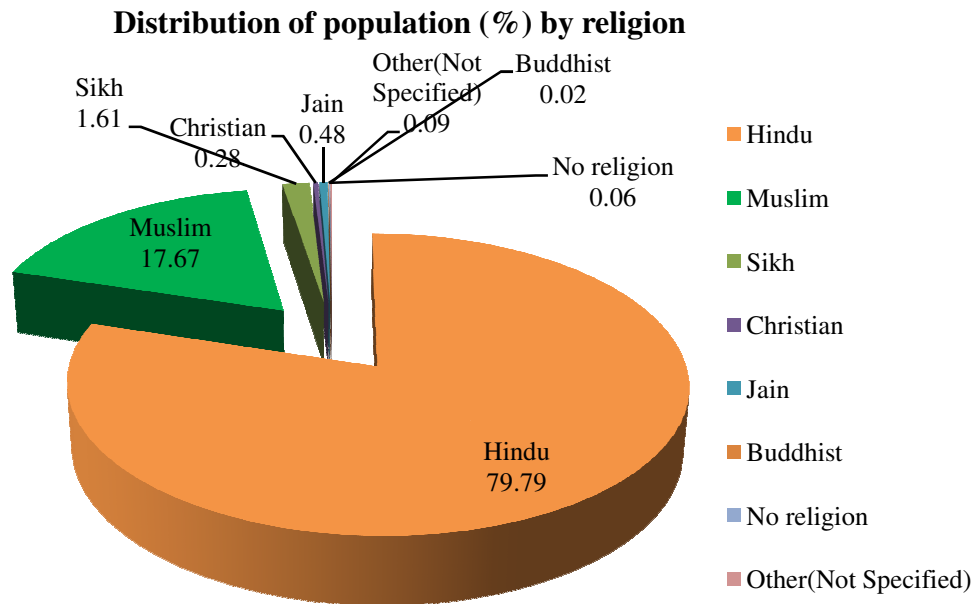


3.1.3 Religion

5. Profile of the population by religion is an important socio-cultural and demographic feature. The highest proportion of population of Delhi is Hindu (79.79%), followed by Muslim (17.67%), Sikh 1.61% and Jain 0.48%. Simultaneously, the lowest proportion of religion being followed by population in Delhi is Buddhist (0.02%), whereas, 0.06% population does not follow any religion.
6. The highest proportion of Hindu population (93.39%) is found in South West district followed by 92.11% in New Delhi districts of Delhi. Whereas, the highest proportion of

Muslim population is reported as 36.67% in North East district followed by 33.21% in South East district of Delhi.

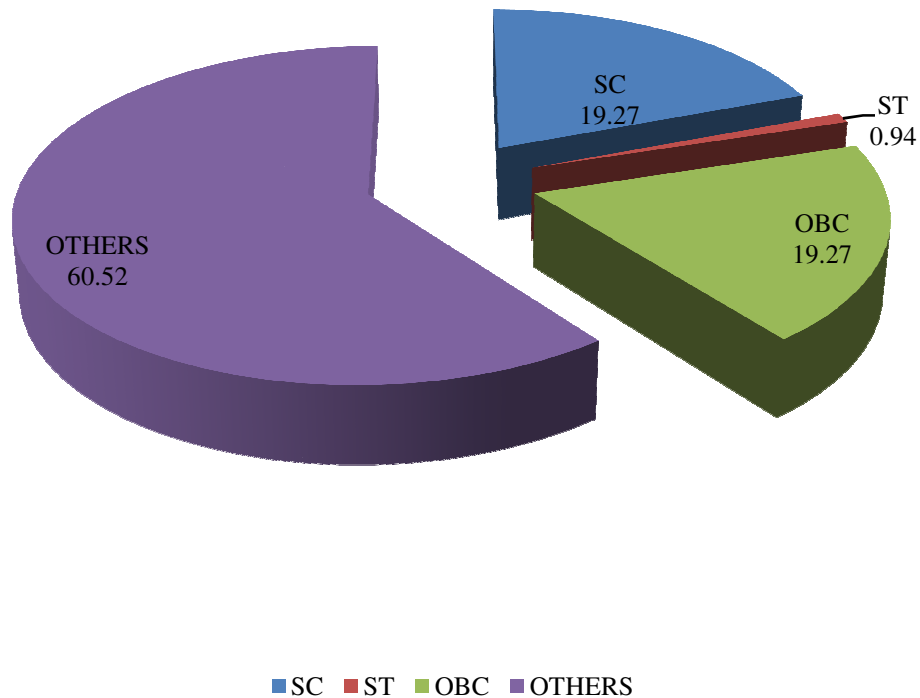
- The highest proportion of Sikh population i.e. 6.58% has been reported in West district whereas the highest proportion of Jain population i.e. 1.15% has been reported in each East and Shahdara districts of Delhi.



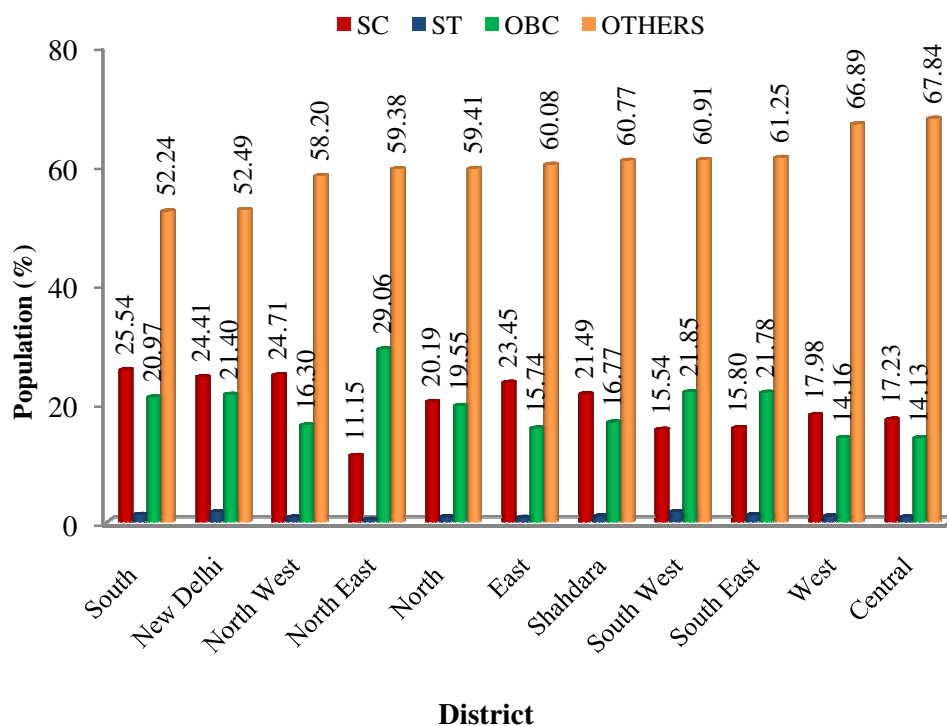
3.1.4 Social Group/ Category

8. 60.52% of the population in Delhi belongs to Others/General category followed by 19.27% in each of SC category and Other Backward Classes.
9. The highest proportion of SC population i.e. 25.54% has been reported in South district followed by 24.71% in North West district of Delhi, whereas the highest proportion of OBC population has been reported as 29.06% in North East district of Delhi followed by 21.85% in South West district.
10. The highest proportion of population belonging to 'Others Category' is reported as 67.84% in Central district of Delhi followed by 66.89% in West district.

3.1.5 Employment Scenario

District wise proportion of persons employed in different occupational categories has been given in below mentioned table.

11. The highest proportion i.e. 24.04% persons are working as Regular-wages/salaried followed by 5.42 % persons working as Other casual wage labour/Contractual worker.
12. The Labour Force Participation rate has been reported as 48.61% whereas the Unemployment rate has been reported as 16.25%.

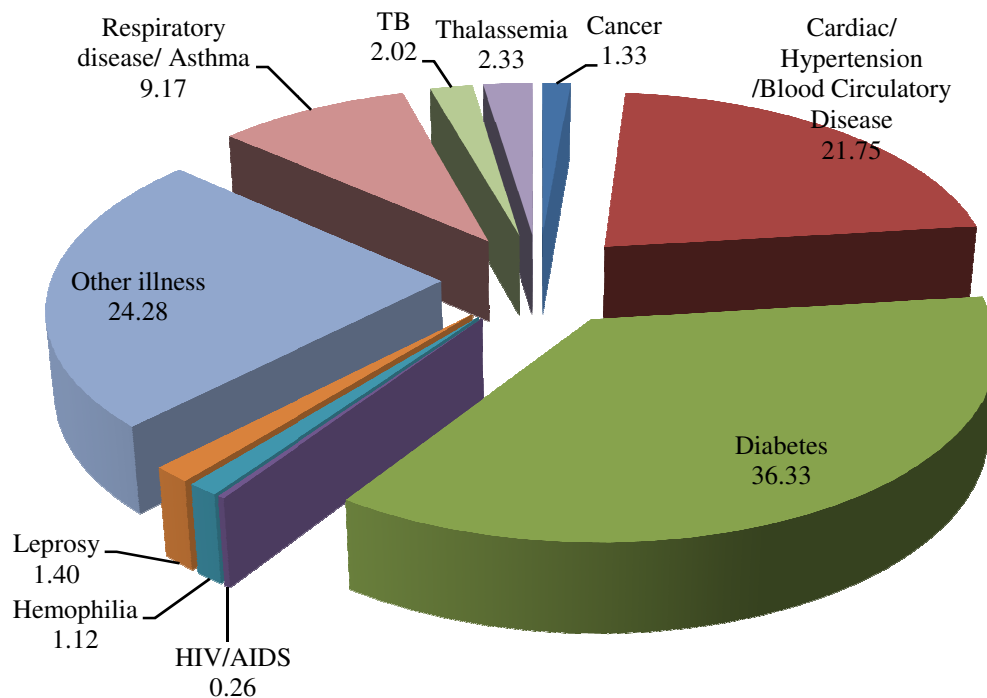

3.2 Health Sector

3.2.1 Chronic illness

13. A chronic illness is a human health condition or disease that is persistent or otherwise long-lasting in its effects or a disease that comes with time. The term chronic is often applied when the course of the disease lasts for more than one month. In Delhi, 2.60% of the total population is suffering from some kind of chronic illness. Out of these persons, 50.29% are male and 49.71% are female.
14. The highest proportion of population with chronic illness (36.33%) is suffering from diabetes followed by 21.75% from cardiac illness (including hypertension and blood circulatory disease) and 9.17% from respiratory diseases. Moreover, 24.28% from population is reported to be suffering 'other illness', which includes the persons with joint pain/arthritis etc.

Distribution of population by type of chronic illness



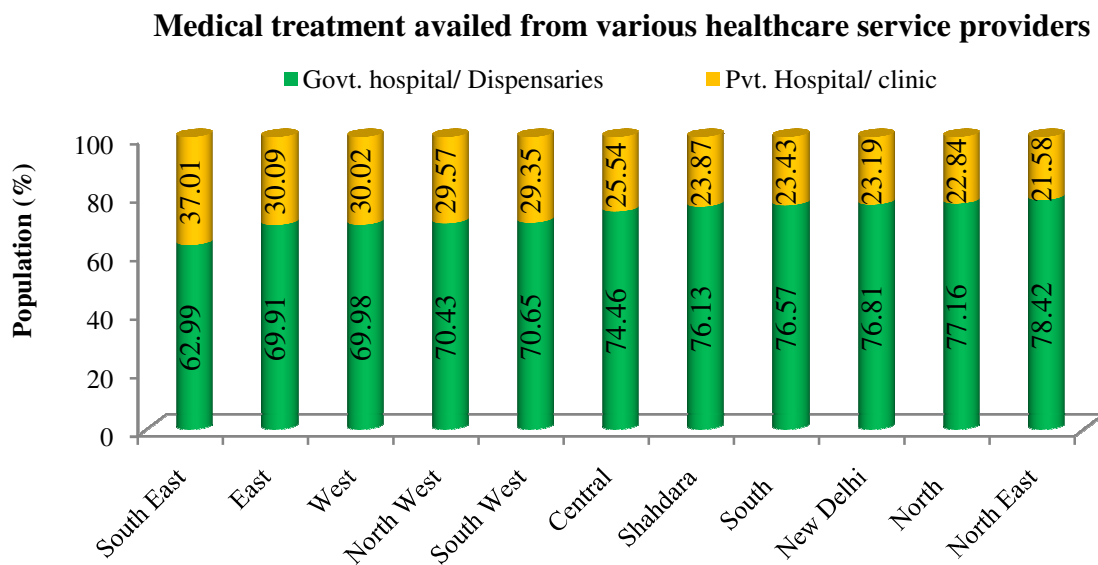
15. The highest proportion of diabetes patients in Delhi has been reported as 43.34% in Central district and the highest proportion of cardiac patients is 26.20% in North West district. Further, the highest proportion of patients with respiratory disease is 11.56% in North district.

16. Among males, the proportion of diabetes as chronic illness has been reported as 37.12% in comparison to 35.53% in females. The proportion of other illness (including joint pains) is 23.52% in males and 25.05% in females. The proportion of cardiac illness (including hypertension /blood circulatory disease) among males is 23.52% as compared to 25.05% in females of Delhi.

3.2.2 Medical treatment availed from type of Healthcare service providers

The Health and Family Welfare Department of Government of NCT of Delhi has tremendous health care responsibilities. The department caters to health needs of ever growing population of the metropolis and also has to share the burden of migratory as well as floating population from neighbouring states.

17. It has been reported that 72.87% population in Delhi is availing medical facility from Government Hospitals/Dispensaries for treatment whereas only 27.13% population in Delhi is getting medical treatment from Private Hospitals/Clinics etc.(Annexure: Table 9).



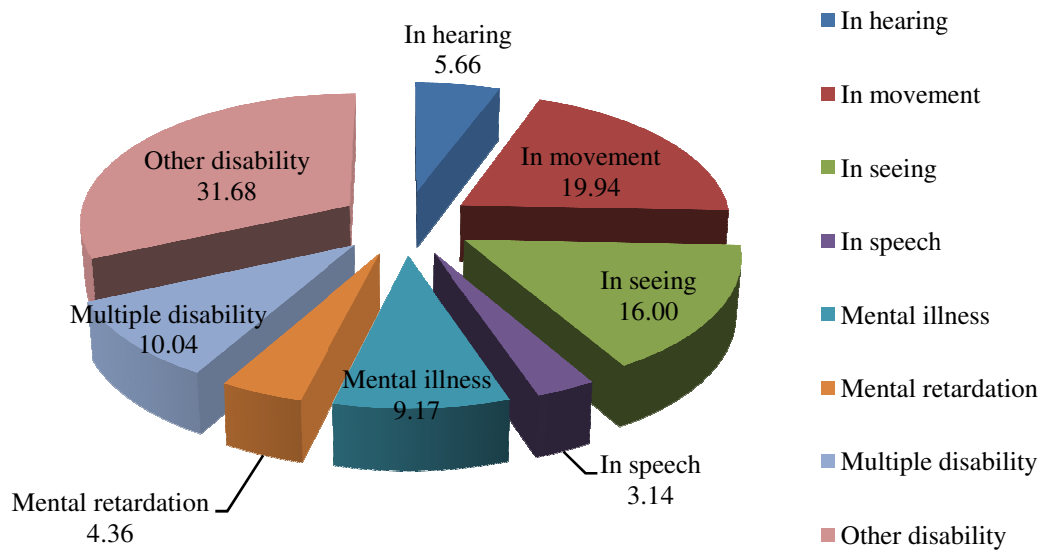
18. The highest proportion of population i.e. 78.42% availing medical treatment from Government Hospitals/Dispensaries has been reported in North East district of Delhi followed by 77.16 % in North District.

19. Whereas, the highest proportion of population getting medical facility from Private Hospitals has been reported as 37.01% in South East district followed by 30.09% in East district of Delhi.

3.2.3 Disabled Persons

A disability is a condition or function judged to be significantly impaired related to the usual standards of an individual or group. The term is used to refer to individual functioning, including physical impairment, sensory, cognitive and intellectual impairment etc.

20. It has been reported that there are 0.80% persons in Delhi suffering from some kind of disability. However, out of total disabled persons the highest proportion i.e. 19.94% is having disability in Movement, followed by 16.00% having Visual disability and 9.17% having Mental illness.

21. The highest proportion of persons with disability in Movement has been reported as 28.87% in North district, the highest proportion of persons with visual disability has been reported as 29.24% in North East district and the highest proportion of persons with Mental illness has been reported as 11.99% in East district.
22. The largest proportion of persons having Multiple disability has been reported as 19.81% in East district followed by 12.03% in West district and 11.08% in Central district of Delhi.
23. Out of Total disabled persons 33.43% persons are having disability certificate and among these disabled persons 50.06% are receiving financial assistance from Government of NCT of Delhi.

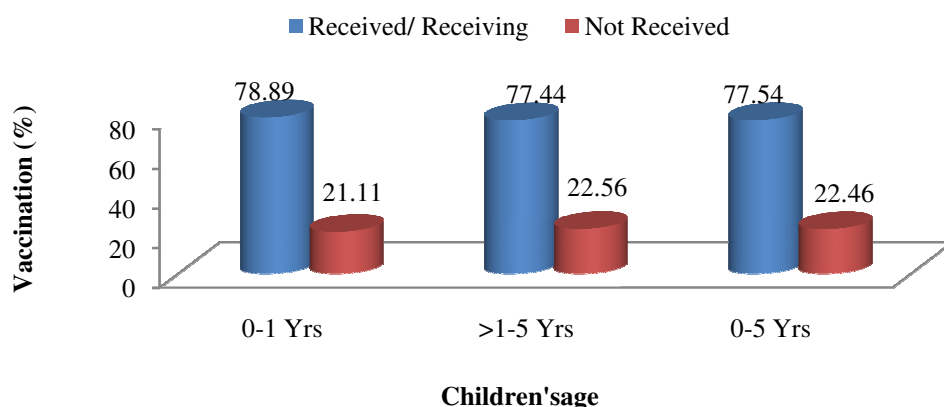

3.2.4 Immunization of Children

Routine immunisation services in Delhi are available twice a week (Wednesday and Friday) regularly at 650 healthcare facilities (Dispensaries) and on all working days in Government hospitals. Delhi is the only state, to have included through its own resources, vaccines of Measles, Mumps and Rubella (MMR)(in 1999), Typhoid(in 2004). All these additional services are a strategy in itself when it comes to improved child survival. Immunization drive “Mission Indradhanush” was launched during the month of April 2015 with an aim to provide vaccination to already vaccinated/partially vaccinated children up to 2 years of age with a due focus on high risk areas.

24. The proportion of children aged 0-5 years out of total population of Delhi is 9.26%. In this age group there are 53.49% male, 46.49% female and 0.02% third gender. Overall 77.54 % children in the age group 0-5 years have received/ are receiving vaccination.
25. In the age group 0-1 year, 78.89% children are reported to be receiving/have received vaccination. In this age group 79.12% female and 78.70% male children are receiving/have received vaccination. At district level, the highest proportion of children in this category i.e. having received/receiving is reported as 82.59% in North East district followed by 81.97% in East district of Delhi.

26. 77.44% children in the age group of 1-5 years are reported to be receiving/have received vaccination. Among these children the highest proportion of children has been reported as 80.79% in East district followed by 80.17% in North district. In the age group (1-5 year), 77.68% female and 78.70% male children are receiving/have received vaccination.

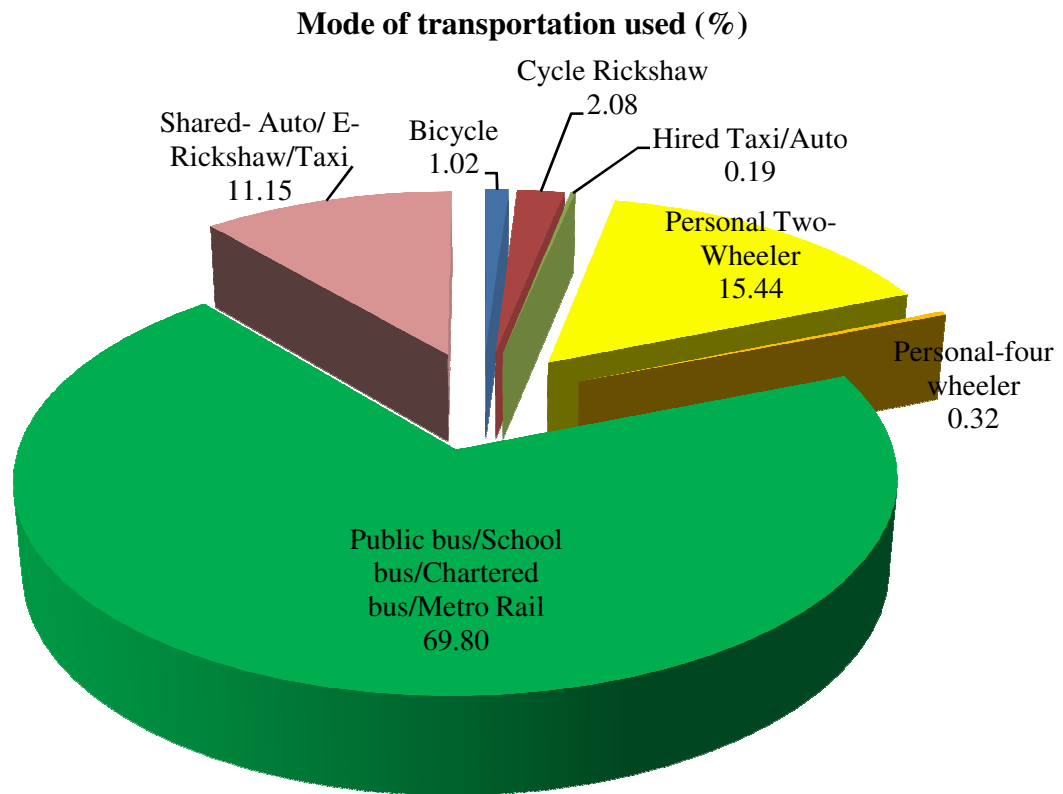
3.3 Transport Sector

3.3.1 Use of transport facility for commuting to work place, educational institutions/other places

Delhi being the capital and a metropolis is always burdened with the pressure to improve public transportation system. It is one of the key agenda of Government of NCT of Delhi.

27. The largest proportion of population i.e. 69.80% is using Public bus/School bus/Chartered bus/Metro Rail for commuting to work place, educational institutions/other places followed by 15.44% population using Personal Two Wheelers and 11.15% population commute through Shared Auto Rickshaw/E-Rickshaw/Taxi.

28. The top three districts where population is reported to be using Personal Two Wheelers for commuting are 21.51% in Shahdara followed by 18.37% in East and 16.54% in West district of Delhi.



29. The highest proportion of population using Public bus/School bus/Chartered bus for commuting to work place, educational institutions/other places has been reported as 75.18% in North district followed by 71.55% in New Delhi and 71.15% in South East district.
30. The highest proportion of commuters using Metro in Delhi has been reported as 10.89% in New Delhi district.
31. 68.34% female population in Delhi is reported to be commuting through Public buses whereas 14.69% through Shared Auto Rickshaw/E-Rickshaw/Taxi followed by 6.78% through Personal Two Wheelers and 6.74% use Metro Rail.

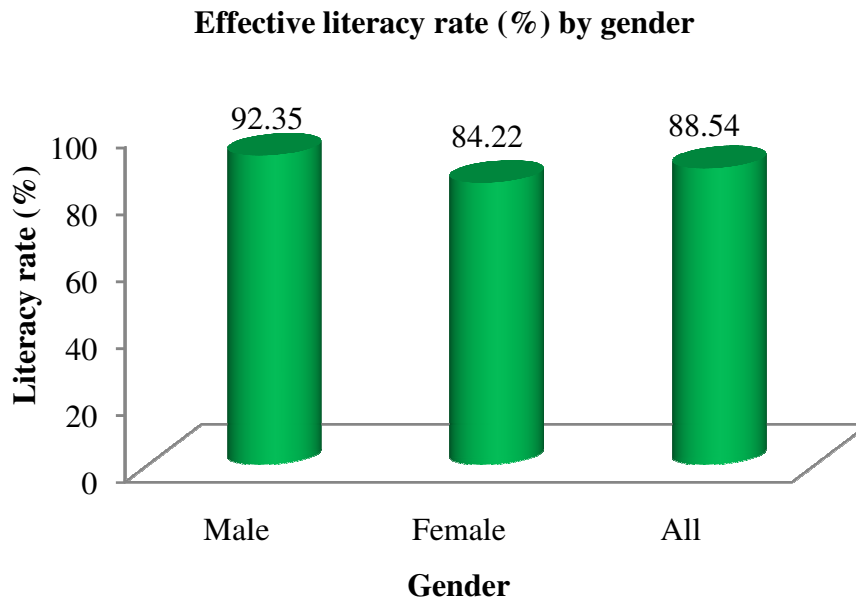
3.4 Education

Crude literacy rate is the total percentage of the people of an area at a particular time who can read and write with understanding, taking the total population of the area (including below seven years of age) as the denominator.

32. The overall Crude Literacy Rate (CLR) in Delhi is 85.78% whereas the CLR for male population is 89.19%, for females it is 81.92% and for third gender it is 73.41%.

The effective literacy rate is the total percentage of the population of an area at a particular time aged 7 years or above, who can read and write with understanding. Here, denominator is total population aged 7 years or more.

33. In Delhi, the effective literacy rate is 88.54%. Simultaneously, the effective female literacy rate is 84.22%, effective male literacy rate is 92.35%.



34. The highest literacy rate among male population has been reported as 95.37% in South-West district followed by 94.00% in East district and 93.91% in South district of Delhi.

35. Among females, highest literacy ratio has been reported as 87.30% in South West district followed by 87.13% in East and 86.61% in Central district of Delhi.

3.4.1 Enrolment status of children of Age group 6-17 years in educational institutions

36. Out of total Children in the age group 6-17 years, 90.24% children are reported to be presently enrolled and attending the educational institutions whereas 5.80% children are presently not attending/have attended before/ drop out and 3.97% have never attended or have never been enrolled in any educational institutions (Annexure: Table 17).

37. It has been noticed that the highest proportion of children i.e. 92.67%, in the category of presently attending/enrolled in educational institutions has been reported in South West district. Whereas the highest proportion of children i.e. 6.89% in the category ‘presently not attending/attended before/drop out’ has been reported in North district. Further, the highest proportion of children in the category ‘never attended/never enrolled’ has also been reported in North District of Delhi as 5.30%.

38. In the Age group of 6-10 years, 93.10% children are reported to be currently attending educational institutions, 2.39% are reported to have ever attended but currently not

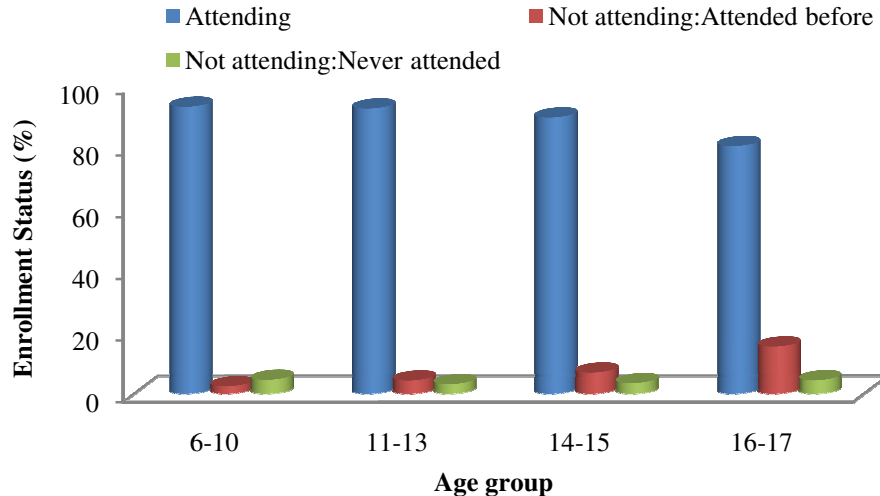
attending where as 4.51% children are reported to have never attended educational institutions.

39. In the Age group of 11-13 years, 92.55% children are reported to be currently attending educational institutions, 4.29% are reported to have ever attended but currently not attending whereas, 3.17% children are reported to have never attended any educational institution.

40. In the Age group of 14-15 years, 89.65% children are reported to be currently attending educational institutions, 6.88% are reported to have ever attended but currently not attending whereas 3.47% children are reported to have never attended any educational institutions.

41. In the Age group of 16-17 years, 80.34% children are reported to be currently attending educational institutions, 15.30% are reported to have ever attended but currently not attending whereas 4.36% children are reported to have never attended any educational institutions.

Educational level wise enrollment status



42. The highest enrolment rate for currently attending children in age group 6-10 and 11-13 years is reported as 94.90% and 93.57% in New Delhi and North East district respectively. However, in the age group of 14-15 and 16-17 highest enrolment rate is reported as 93.33% and 86.91% respectively in South district.

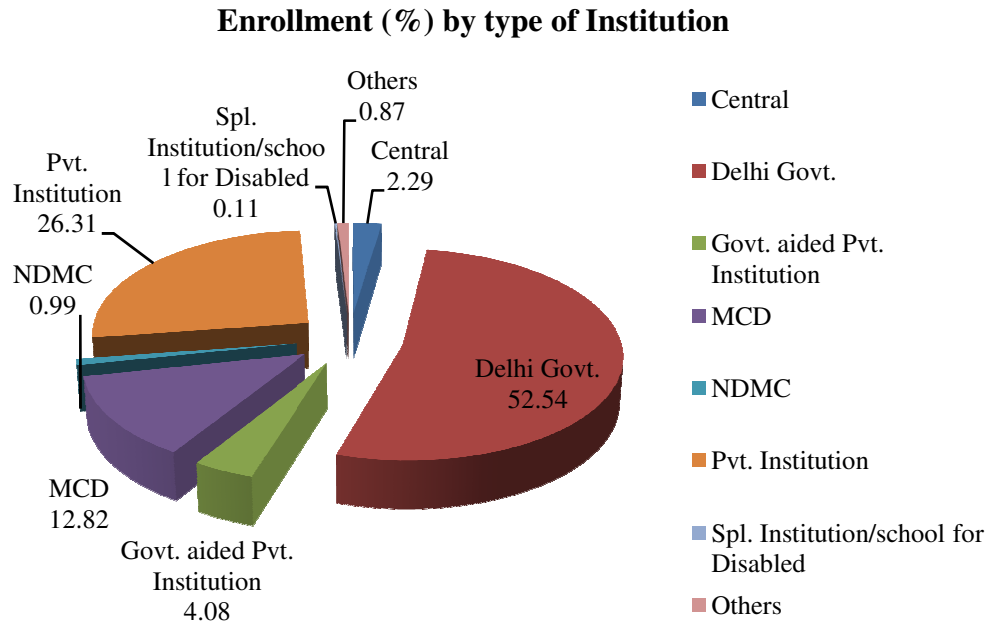

3.4.2 Enrolment in educational institutions by type of institutions

43. The highest proportion of students i.e. 52.54% in the age group 6-17 years are currently enrolled in schools run by Education Department of Government of NCT of Delhi, followed by 30.39% enrolled in Private Schools (including 4.08% in Government aided Private Schools) and 12.82% enrolled in MCD Schools.



3.4.3 Percentage distribution of Out of school children (Dropout/Discontinued/Never attended) by different age groups

A dropout is a pupil who leaves school before the completion of a school stage or leaving at some intermediate or non-terminal point of a given level of education (school stage). This term dropout has been used in two senses. It may mean either: (i) one who has discontinued education after completing the last level of education for which, he/she was enrolled or (ii) one who has discontinued education before attaining a specific level. According to the first definition, for example, if a person has completed the upper primary level but does not enroll for higher education, he/she is not considered a dropout. It is considered as a case of discontinuation. However, if the person enrolls for the secondary level but does not complete it, then he/she is

considered a dropout. Out of school children denote dropout/discontinued/never attended children in the age group of 6-17 years.

44. Out of total population, 22.15% population is in the age group of 6-17 years. In this age group, 9.76% children are reported to be Out of school i.e. dropout/discontinued/never attended. The children in the age group have been divided into four Sub-groups i.e. 6-10, 11-13, 14-15 and 16-17 years.

45. It has been noticed that the highest proportion of Out of school children is reported as 33.55% in the age group of 16-17 years followed by 29% in 6-10 years, 18.92% in the age group 11-13 years and 18.53% in the age group of 14-15 years.

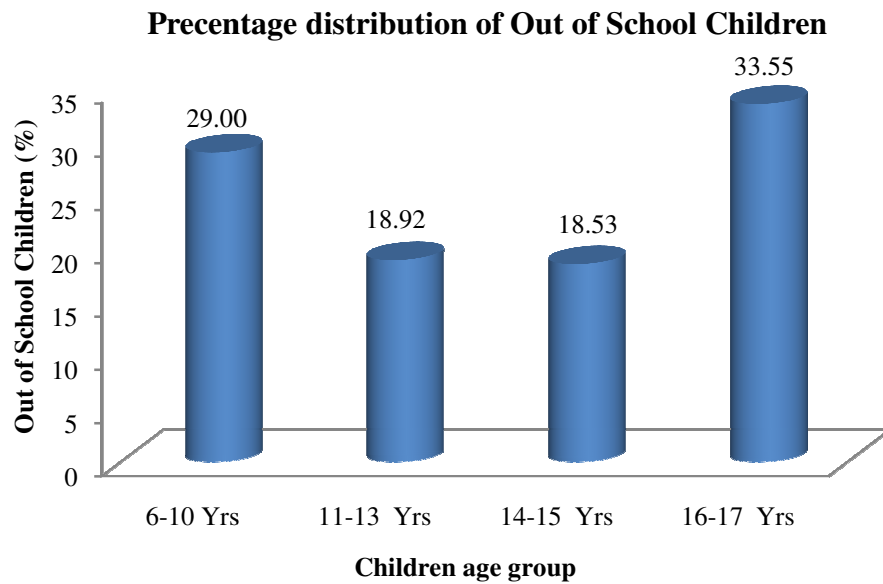
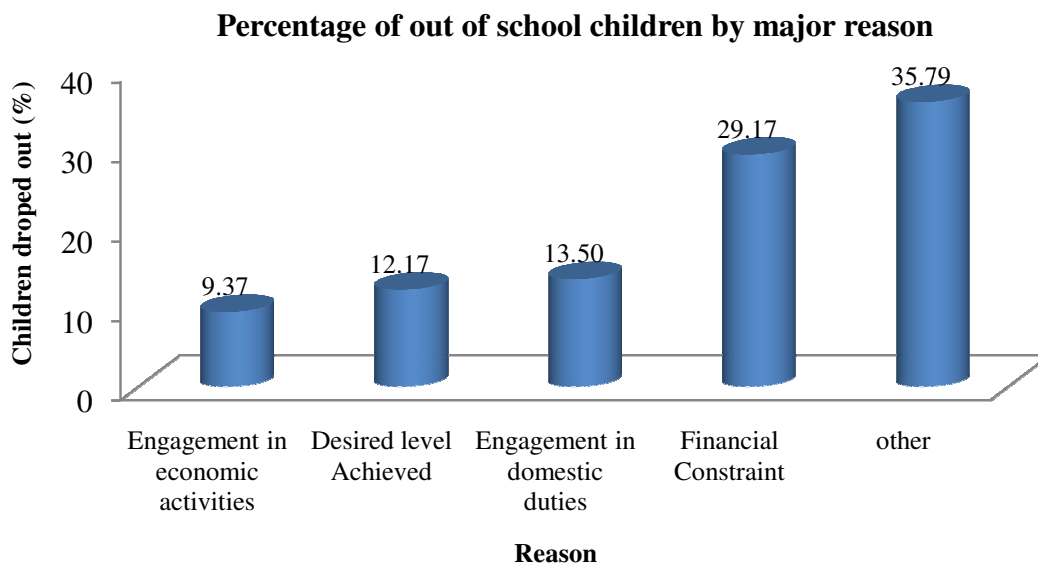

3.4.4 Reason for Out of school children (dropout/discontinued/never attended) in the age group 6-17 years



46. Among the Children in the age group 6-17 years, 9.76% are reported to be Out of school (dropout/discontinued/never attended the educational institution) in Delhi. The prominent

reason for Out of school children in this age group has been reported as 29.17% on account of Financial constraint followed by 13.50% on account of Engagement in domestic duties and 12.17% on account of the reason that the Desired level of education has been achieved. Further, 35.79% of the children have reported “Others” as a reason for dropout in this age group. On detailed analysis, it has been found that reason in the “Others” category includes disability, mental illness, not interested, no admission and in some cases reason not stated.

3.4.5 Gross Attendance Ratio (GAR) in age group 6-17 years by level of education

47. GAR is the number of students attending a given level of education at any time during the reference academic year, regardless of age, expressed as a percentage of the official school-age population corresponding to the same level of education.
48. GAR in the age group of children aged 6-17 years has been reported as 99.48%. The highest proportion of GAR in this age group has been reported as 106.88% in South district.
49. GAR at Primary, Upper primary/Middle, Secondary and Senior secondary/Higher secondary level of education are reported as 101.83%, 98.32%, 104.85% and 89.78% respectively.

Gross Attendance Ratio (GAR) at different level of education

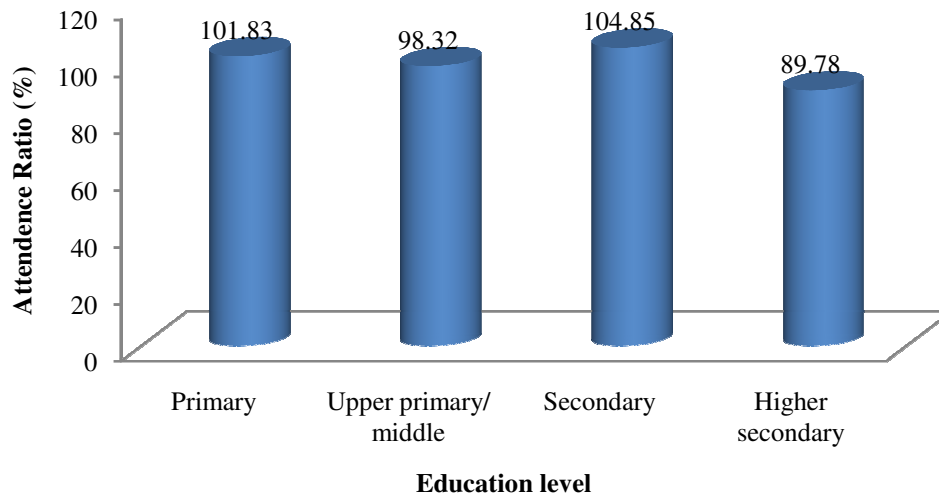

3.4.6 Enrolment status of Adolescent Girls (age 11-14 years)

50. 92.47% of Adolescent Girls in Delhi are reported to be currently enrolled/attending in educational institutions, whereas 4.44% adolescent girls are reported to be not attending/attended before and 3.09% girls in this category have never attended/were never enrolled in the educational institutions in Delhi.

51. The highest proportion of Girls currently attending educational institutions in this age group has been reported as 93.35% in South district whereas the highest proportion of Girls in this age group who have never attended educational institutions has been reported as 4.12% in North district of Delhi. In total 7.53%, Adolescent Girls are Out of School.

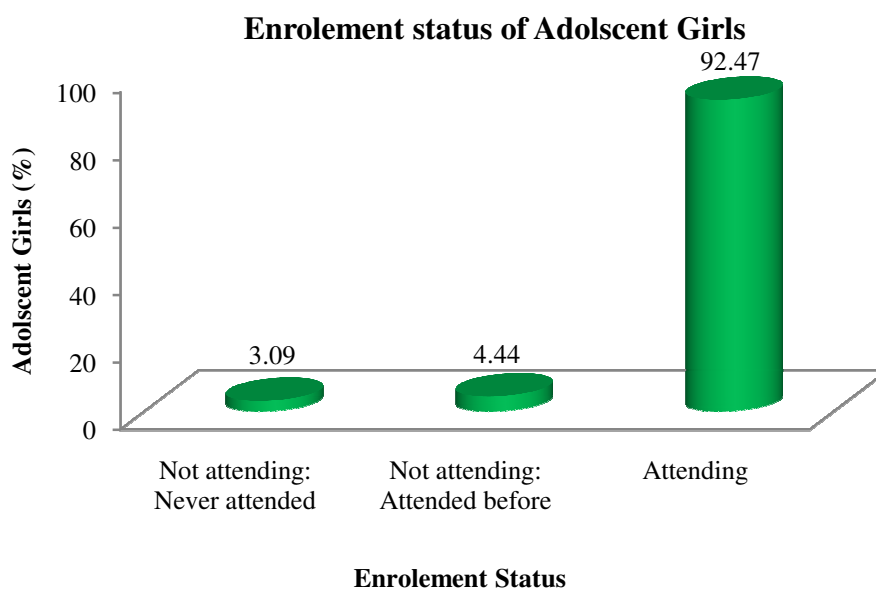
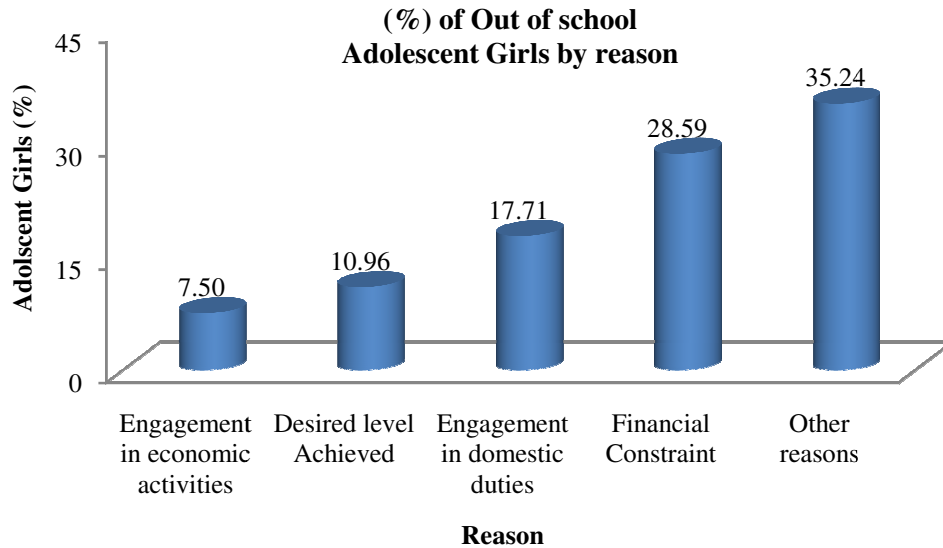

52. Out of total Adolescent Girls in the age group of 11-14 years in Delhi, about 7.53% Girls are Out of school. The major reason for dropout/discontinued/never attended Adolescent Girls in any educational institutions in Delhi has been reported as financial constraints (28.59%) followed by Engagement in household duties (17.71%), Desired level achieved (10.96%) and Engagement in economic activities (7.50%). It has been further reported that 35.24% of the adolescent, Out of school girls have reported “Others” as reason for dropout. The “Others” category of reason for dropout includes disabled, mental illness, not interested, no admission and in some cases detailed reason has not been stated.
53. The highest proportion of reason (financial constraint) for Out of school Adolescent Girls has been reported as 37.25%, 33.47% and 32.55% in New Delhi, East and Shahdara districts of Delhi.

3.5 Social Welfare Sector

The Government of NCT of Delhi is implementing, to attain the objectives laid down in directive principles of state policy on social security, schemes/ programs to ensure the welfare of weaker sections of the society, disadvantaged groups and physically challenged persons for better care and support. The Government is implementing schemes and programs for empowerment of women, security to aged people and vulnerable sections and creating an enabling environment for children. The social welfare department deals with the matters pertaining to the welfare of senior citizens, physically challenged persons and other vulnerable sections of the society. The Women and Child Development (WCD) department, GNCTD deals with matters pertaining to the women and children.

Integrated Child Development Scheme (ICDS) was launched on 2nd October 1975. Today, the ICDS scheme represents one of the world's largest and most unique programs for early childhood care and development. It is the foremost symbol of country's commitment to its children and nursing mothers, as a response to the challenge of providing pre-school non-formal education on one hand and breaking the vicious cycle of malnutrition, morbidity, reduced learning capacity and mortality on the other. ICDS program provides six services including supplementary nutrition, immunization, health checkup, referral services, and nutrition and health, education that are being provided through 10897 Anganwadi Centres. The ICDS is a centrally sponsored scheme and cost sharing between Centre and State is 50:50 for supplementary nutrition component and 60:40 for other than nutrition components. The beneficiaries under the scheme are children in age group 0-6 years, pregnant women and lactating mothers.

3.5.1 Distribution of Children aged 0-6 years attending Anganwadi Centre (AWC)

54. The proportion of children in the age group of 0-6 year out of total population of Delhi is 11.04%. In this group, 55.40% children are reported to be attending Anganwadi Centre (Annexure: Table 25).
55. The highest proportion of children attending Anganwadi Centres is reported to be 60.76% in Shahdara district followed by 60.01% in West district and 59.16% in North district of Delhi.

3.5.2 Senior citizens availing pension

56. Delhi Government provides old age financial assistance to the persons of the age 60 years and above subject to fulfilling of eligibility criteria.

57. The proportion of senior citizens out of total population of Delhi is about 5.41%. Among these senior citizens, 43.28% are availing old age pension from GNCT of Delhi. In total, 41.69% male and 45.12% female senior citizens are getting old age pension.

58. The highest proportion of females availing senior citizen pension is 52.10% in West district followed by 50.99% in North district. Simultaneously, the highest proportion of male availing senior citizen pension is 48.12% in South district followed by 47.66% in West district of Delhi.

Senior citizen availing pension

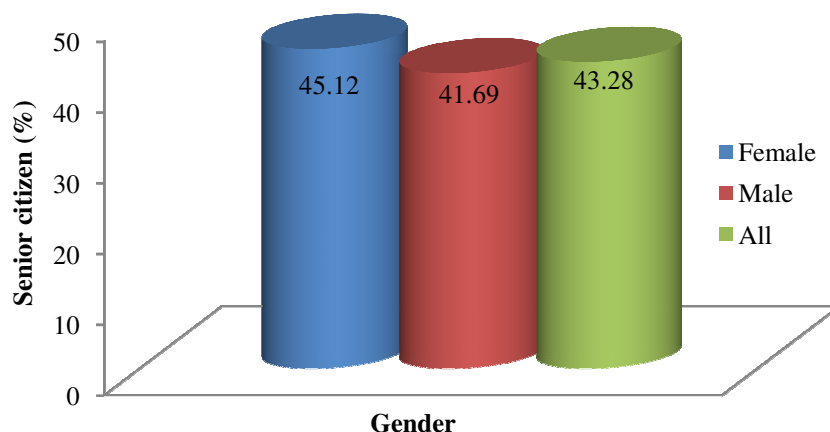

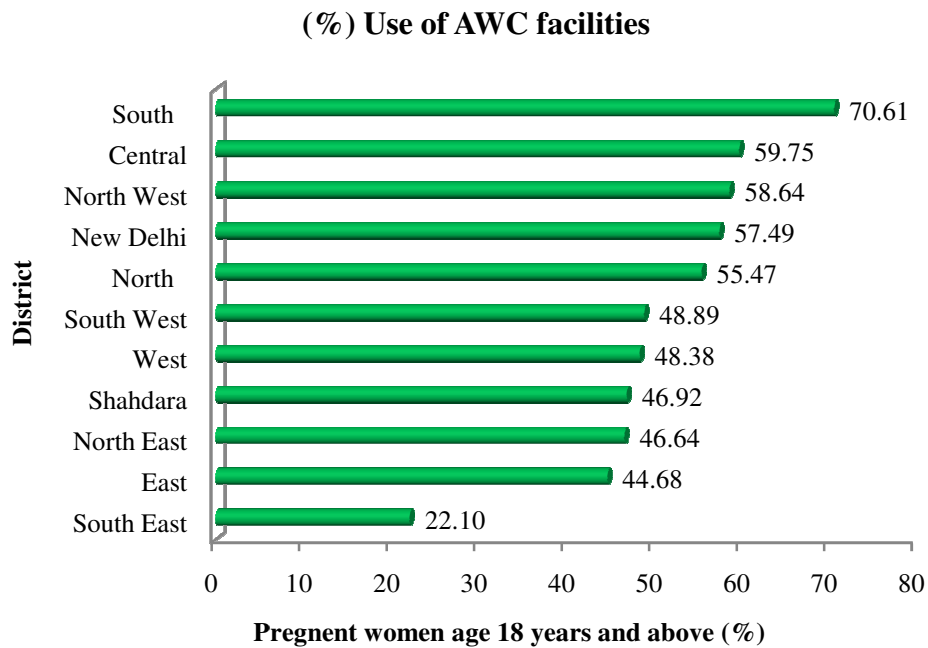

3.5.3 Use of Anganwadi Centre (AWC) facility by pregnant Women

59. Anganwadi is a type of mother and childcare centre in India. They were started by the Indian Government in 1975 as part of ICDS to combat child hunger and malnutrition. These Centres provide supplementary nutrition, non-formal pre-school education, immunization, health checkup and referral services etc.

60. It has been reported that among pregnant women aged 18 years and above, 47.15% women are attending Anganwadi Centres in Delhi (Annexure: Table 27).

61. Among these women the highest proportion of pregnant Women attending Anganwadi Centres is reported as 70.61% in South district followed by 59.75% in Central district and 58.64% in North West district of Delhi.
