# Sex Work is Dignified Work



To, Hon.Justice H.L.Dattu, Chairperson, National Human Rights Commission, New Delhi, India.

<u>Sub: Petition by the National Network of Sex Workers regarding police brutality and raids on sex workers in</u> Mumbai on 24-25<sup>th</sup> May 2019.

As per media reports, during the intervening night of Friday 24/5/2019 and Saturday 25/5/2019 Mumbai Police raided Simplex building in Grant Road east and arrested 65 customers and 19 brothel owners. During this violent raid one women in sex work who tried to escape from the rescuers got injured and is now admitted in a hospital. Police claim to have 'rescued' 141 women in this raid according to media reports.

NNSW condemns any raid by the police that terrorizes sex workers who are in sex work of their own volition. Section 370 IPC is aimed at protecting women and children from being trafficked. It is not targeted at sex workers who practice of their own volition . This clarification was specifically made to the NNSW by the Commission headed by Hon'ble Justice Verma. In its clarification to NNSW, the Commission was categorical the law ought not to be interpreted to permit law enforcement agencies to harass sex workers who undertake activities of their own free will, and their clients.

In the light of this explanation by the Verma Commission of their intention while formulating this law, we demand that the police stop such brutal raids and immediately constitute confidence-building measures among the sex workers such that women do not flee the rescuers. If the intention of the police is to protect women in sex work then they should be proactive about the same rather than terrorize the women into submission. Violent raids are not the answer.

The misuse of anti-trafficking provisions of Section 370 IPC, against adult consenting sex workers and their clients must be condemned. The judiciary needs to take strong action of the misuse of legal provisions that impact the lives of women in sex work
