COVID-19 ASSOCIATED LOSSES TO THE TOURISM SECTOR

959. SHRI PARTAP SINGH BAJWA:

Will the Minister of **TOURISM** be pleased to state:

- (a) whether Government has conducted any research on the financial losses to the tourism sector due to the COVID-19 crisis and if so, the details thereof;
- (b) the number of foreign tourists who visited India during 2019-20 and 2020-21 till present;
- (c) the number of domestic tourists who travelled within India during 2019-20 and 2020-21 till present;
- (d) whether Government provided any incentives or assistance to those engaged in the tourism sector and, if so, the details thereof and, if not, the reasons therefor; and
- (e) the total number of people employed in the tourism sector for the years 2018-19 till present, State-wise?

ANSWER

MINISTER OF TOURISM

(SHRI G. KISHAN REDDY)

- (a): Ministry of Tourism, Government of India got conducted study on "India and the Coronavirus Pandemic: Economic Losses for Households Engaged in Tourism and Policies for Recovery". Key findings of the study are given below:
 - Due to overall economic slowdown during 2020-21, tourism economy or tourism direct gross value added (TDGVA) saw a fall of 42.8 percent in Q1; 15.5 percent in Q2 and fall of 1.1 percent in Q3.
 - Due to significant drop in tourist arrivals and hence tourism expenditure during the pandemic, it is estimated that TDGVA plummeted by as much as 93.3 percent in Q1 of 2020-21 over its level in the same quarter of previous year. It picked up slightly to post a fall of 79.5 percent in Q2 and that of 64.3 percent in Q3.
 - A significant number of jobs were lost in the tourism sector once the lockdown was implemented. 14.5 million Jobs during Q1, 5.2 million during Q2 and 1.8 million jobs during Q3 are expected to have lost as compared to estimated 34.8 million jobs in the pre-pandemic period of 2019-20 (Direct jobs).
- (b): Ministry of Tourism compiles data on Foreign Tourist Arrivals (FTAs) on calendar year basis. As per information received from Bureau of Immigration, the number of Foreign Tourist Arrivals (FTAs) during 2019, 2020 and till June, 2021 are given below:

(c): Ministry of Tourism compiles data on Domestic Tourists Visits (DTVs) on calendar year basis. As per information received from States/UTs administration, the number of Domestic Tourists Visited during calendar year 2019, 2020 are given below:

- (d): Ministry of Finance, GoI has recently announced new loan guarantee to more than 11,000 registered Tourist Guide/Travel and Tourism Stakeholders, so that they could discharge their liabilities and restart business impacted due to COVID-19. Loan will be provided with 100% guarantee upto the following limits:
 - i. Rs. 10,00,000 for TTS (per agency)
 - ii. Rs. 1,00,000 for tourist guides licensed at Regional or State Level
- (e): Ministry of Tourism has got prepared Regional Tourism Satellite Account (TSA) of all States/UTs along with the 3rd TSA of India for the reference year 2015-16. Thereafter, the 4th TSA was supposed to be conducted 2020-21, however, due to Covid-19 pandemic this was not initiated. The total number of people employed in the tourism sector as per regional TSA for States/ UTs for the year 2015-16 are at Annexure.
